

Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding fifty six years as on the closing date of the receipt of applications. Note 2: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1 st January, 2016, the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding level in the Pay Matrix extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised grade pays into one level in the Pay Matrix and where this benefit shall extend only for the post for which that level in the Pay Matrix is the normal replacement grade without any up-gradation.
