ORDER

Based on a complaint filed by Sri. R. Sukumaran, Kerala Public Service Commission had given a complete list of ST candidates advised from the ranked list of LDC (Various) of Kozhikkode district which came to effect on 15.10.1994, for the verification of the Scrutiny Committee. Sri.Rejimon Joseph was included in this short list as SL.No.3.

Subsequently, the Scrutiny Committee directed the Vigilance Cell of Kerala Institute of Research Training and Development Studies (KIRTADS) to conduct a detailed enquiry into the real caste status of Sri. Rejimon Joseph and the Vigilance Officer, KIRTADS submitted a

detailed anthropological enquiry report.

The Scrutiny Committee, in its meeting held on 06/11/2024, examined the entire case records and all the relevant documents produced along with the enquiry report of the Vigilance Officer, KIRTADS, in accordance with the provisions of Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Act, 1996 (Act 11/1996) and also heard the incumbent officer. The Anthropological enquiry report and the local enquiry conducted in and around Kandathiplackal (H), Manakkad P O, Thodupuzha revealed that the parents and both paternal and maternal grandparents of the claimant belong to Scheduled Tribe (Malai Arayan) community and the claimant and his family members are in the fold of Scheduled Tribe (Malai Arayan) community converted to Christianity. The Genealogical and documentary evidences enclosed with the enquiry report substantiated that the Claimant belongs to Scheduled Tribe (Malai Arayan) community. Hence, the Scrutiny Committee accepted the Scheduled Tribe (Malai Arayan) claim of Sri.Rejimon Joseph, Kandathiplackal (H), Manakkad P O, Thodupuzha, Idukki District and also authorised the Chairman to issue Proceedings in this line.

In the circumstances, orders are hereby issued, accepting the Scheduled Tribe (Malai Arayan) claim of Sri.Rejimon Joseph, Kandathiplackal (H), Manakkad P O, Thodupuzha, Idukki District.
