- The discount offered by the firm for each item shall be quoted specifically against each title. The quotation offering the highest discount will ordinarily be accepted. However, the High Court reserves the right to reject all or any one of the quotations without assigning any reason.
 - 2. Withdrawal from the quotation after its acceptance or failure to supply books within a period of three-weeks from the date of the order of purchase by this office or according to the specifications will entail cancellation of the order and for any loss incurred for the subsequent purchases at the offerer's expenses from elsewhere, the defaulting party shall be liable. In such an event the High Court of Kerala reserves also the right to remove the defaulter's name from the list of suppliers permanently or for a specified number of years.
 - 3. No representation for enhancement of price once accepted will be considered during the currency of the contract.
 - 4. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
