The pre-qualification/technical bid shall be opened online at the office of Deputy Chief Engineer, Generation Circle, Kothamangalam on the date and time mentioned above or modified and communicated through corrigendum, in the presence of the bidders /their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or nonworking day due to any other valid reason, the tender opening process will be done on the next working day at same time and place. After evaluation of the pre-qualification documents, the price bid of the qualified bidders will be opened and evaluated.
