- 1) All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority. More details about e- tendering procedure will be available from National Informatics Centre, Thiruvananthapuram on all working days from 10.30 am to 5.30 pm. (Phone No.0471-2577088, 2577188, 91-9995755177).
- 2) The bid documents and other details can be down loaded from the website www.etenders.kerala.gov.in .
- 3) The Earnest Money Deposit (EMD) for an amount of **Rs. 15100/-** and a non-refundable tender document fee of **Rs. 1534/-** (including 18% GST), total **Rs. 16634/- (Rupees Sixteen Thousand Six Hundred and Thirty Four only)**
- 4) shall be remitted on line to the account number in the remittance form provided by the e-Procurement system for this particular tender. **Only NEFT & RTGS remittance is allowed.** The NEFT facility for online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system. Mode of payment other than NEFT/ RTGS will not be allowed. Separate or split remittance for tender document fee and EMD shall be treated as invalid transactions. Kerala Government Public Sector undertakings are exempted from furnishing EMD.
- 5) The offers shall be submitted in Single Bid system.
