Kerala Government Public Sector Undertakings are exempted from furnishing EMD. All SSI Units within Kerala and which are registered with Stores Purchase Department for the products for which registration is valid are exempted from remitting EMD. MSME with Udyog Aadhar Registration are exempted from furnishing EMD and Bid Submission fee. Valid documents to claim EMD exemption shall be submitted as proof including MSME Registration certificate with Udyog Aadhar. All Communications shall be addressed to the Chief Engineer (P&SCM) only.

The Bid documents and other details may be downloaded from the website www.etenders.kerala.gov.in. Bidders are advised to visit the "Downloads" section of the website also. The EMD and non-refundable Bid submission fee of Rs.44,250/- (including GST@ 18%) shall be remitted online to the account number given in the remittance form provided by the e-procurement system for this particular bid. State Bank of India Multi Option Payment System (SBI MOPS Gateway) alone is allowed as Mode of payment. EMD amount above Rs.10 Lakhs can also be submitted as Bank Guarantee (BG) in stamp paper worth of Rs.500/-, with a minimum

validity of 9 months from the date of opening of Pre-qualification Bid and a maximum up to the date of execution of Agreement.

(Bidder should ensure that bid submission fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for bid document fee and EMD shall be treated as invalid transactions, and system will automatically reject the tender. However this is not applicable in case EMD is submitted as Bank Guarantee.)

Bidders are cautioned to quote both of the Electrical Circles in the yard for both 8m & 9m PSC Poles that the bidder chooses to quote. Partial pricing with respect to given circles shall disqualify the bidder.

All Bid documents are to be submitted online only and in the designated covers/envelopes on the above website. Technical bid and financial bid shall be submitted in their designated online covers. Bid shall be accepted only through online mode in the website and no manual submission shall be entertained.

The scanned copy of Bid Agreement as per Appendix -III - General Conditions of Contract and Schedule for the supply of materials and bid form mentioned in Annexure -II of price bid Part-III, both executed in Kerala Stamp paper worth Rs.200/- each are to be uploaded along with the bid. For claiming EMD exemption, scanned copy of MSME Registration with Udyog Aadhar Number also to be uploaded along with bid form and bid agreement. The pre-qualification/technical bid shall be opened online at the Corporate Office (Procurement & Supply Chain Management) on the date and time mentioned above by the Chief Engineer (P&SCM). All other existing conditions related to the bids of KSEB Ltd will be applicable in this bid also.

Originals of Bid Agreement and bid form in stamp paper worth Rs.200/-and Bank Guarantee towards EMD enclosed in a sealed envelope indicating Bid No. KSEB/SCM/eP.44/2024-25 dated 30/09/2024 shall be submitted to the office of the Chief Engineer (P&SCM), before the last date of Pre-qualification Bid opening.

All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved Certifying Authority.
