The MOPS facility for online payment may be exercised at least 48Hrs before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

Any liability on the difference in compensation amount payable before the commissioner for workmen's compensation (Deputy labour Commissioner) or the victim beyond the insurance claim amount sanctioned by the Insurance Company rest with the contractor who has engaged the victim.

All other terms and conditions existing in Kerala State Electricity Limited for similar tenders are applicable to this also.
