Bidder should ensure that tender document fee (Rs. 5,900/-) and EMD (Rs. 50,000/-) are remitted as **one single transaction (ie Rs. 55,900/-)** and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transaction. EMD cannot be furnished as BG. The **Internet Banking** facility for online payment may be exercised at least 48 hours before the closing date of the bid submission to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.
- The bid shall be submitted online and duly filled bid documents shall be uploaded in their designated online cover. The Bid shall be accepted only through online mode.
- **The scanned copies of Bid form as per form 'D', preliminary agreements (bounden agreement) executed in stamp paper worth Rs. 200/- as per form 'A', certificate of experience, solvency, average annual turnover and all certificates /documents mentioned elsewhere in the bid document are to be upload along with the bid through online.**
