TERMS AND CONDITIONS

- Ø The contractor should mandatorily specify the GST registration status and to quote GST Registration Number along with the copy of GST Registration Certificate. If the contractor is an GST unregistered person, a declaration should be uploaded while submitting a tender.
- Ø In cases where the bidders participating in this Tender consist of both GST registered and non-registered bidders, the Tender shall be evaluated based on the total cash outflow to KSEBL. That is, the rates quoted by contractors excluding Taxes plus the prevailing GST (for registered parties) should be taken into consideration for the purpose of determining the L1 bidder.
- Ø In case of tenders having PAC less than or equal to Rs.20 Lakhs, if the GST registration details were not specified by a registered bidder while submitting the Tender, he shall be treated as if he were an unregistered dealer. If the work was awarded to that bidder treating him as an unregistered dealer and at a later stage if it is found that he holds a valid GST registration, he should be insisted to provide GST Invoice indicating the quoted amount and GST and in such a case the quoted amount shall only be reimbursed to him and the GST amount shall not be reimbursed.
- Ø All the tender documents are to be submitted online only and in the designated covers on the above website and no manual submission shall be entertained.
- Ø The rate should remain firm for 6 months from the date of opening of bid as per clause no. 6.1.20 of SCC. The rate should be quoted as per format given in the e-tender portal. The bidder should quote the Rate excluding GST in BoQ.
