

Bidder should ensure that **tender document fee and EMD are remitted as one single transaction and not separate.** Separate or split remittance for tender document fee and EMD shall be treated as invalid transaction. **The payment is only made through State Bank of India Multi-Option Payment System (SBI MOPS Gateway) as online payment**. The online payment may be exercised at least 72 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.
