All communications shall be addressed to the Assistant Executive Engineer, Research & Dam Safety Sub Division No.II, Vazhathope, only. The Bid documents and other details may be downloaded from the website etenders.kerala.gov.in. A total of ₹ 21,688/- (Rupees Twenty One Thousand Six Hundred and Eighty Eight only) (including EMD of ₹ 19,800/- and a non-refundable Bid document fee of ₹ 1,888/- (including GST) shall be remitted online as a single transaction through online e-Payment as specified in the tender documents. The bidder should ensure that bid document fee and EMD are remitted as one single transaction and not separate. Separate or split remittance for bid document fee and EMD shall be treated as invalid transaction and the system will automatically reject the tender. The facility for online payment may be exercised at least 72 hours before the closing

date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

All the Bid documents are to be submitted online only and in the designated covers in the above website. Tenders/ bids shall be accepted only through online mode in the website and no manual submission shall be entertained. Late tenders will not be accepted.

The scanned copies of agreements as per sample Form 'A' of Section 3 of Part-1 of bid attached in Kerala Govt. Stamp Paper worth ₹ 200/- and experience certificate and other documents as specified in the bid documents are to be attached along with the bid. The bid shall be **opened online at the office of the Assistant Executive Engineer, Research & Dam Safety Sub Division No.II, Vazhathope** in the presence of the bidders/ their representatives who wish to attend at the above address, on the date and time mentioned above or the date modified and communicated through the corrigendum. All other existing conditions related to the bids of KSEB Limited will be applicable to this bid also. Tender document can be downloaded from **20.07.2024 at 11.00AM** onwards. The bidding authority reserves the right to modify/cancel any or all bids without assigning any reasons for such decision and will not incur any liability whatsoever on the part of KSEB Limited and will not be responsible for any errors like missing of schedule, data etc. while downloading by the bidder/non receipt of document/delay, if any. Bidders are advised to visit the **“Downloads”** section of the Government of Kerala's e-Procurement website etenders.kerala.gov.in also.

Hard copies of the original bid documents except BOQ duly signed may be submitted to the Assistant Executive Engineer, Research & Dam Safety Sub Division No.II, Vazhathope on or before the due date of opening of the bid.

Price should not be mentioned in any other documents or anywhere else other than in online BOQ". Also, the bidder shall submit the original of any of the documents uploaded in the bid, if so required at any stage of evaluation and award process. If any discrepancy is noticed in the tender submitted by the bidder through online and the hard copy, the tender will be summarily be rejected.

All tenderers participating in the tender should have a valid digital signature certificate availed from an approved certifying authority. Bidders can quote for PAC in the BoQ sheet.

The tenderers should quote the percentage rate of contract.

1. **GST registered Bidders should produce GST Invoice containing all the particulars stated in Rule 46 of the CGST Rules, 2017 along with bid . The GST Registration No, registration status & copy of GST Registration certificate are mandatory while submitting tender. GST rate, GST amount and TCS need not be quoted by the bidder.**

The contractor shall quote the price excluding GST & TCS, and considering all other taxes, if any, applicable. The price has to be quoted, after considering the current market rate and after passing on the benefit of Input Tax Credit, as per section 171 of the CGST Act 2017. The GST Registered persons only shall be eligible to participate in the Tenders with PAC more than Rs.20 Lakhs.

Bidders should thoroughly study the technical specifications and special conditions of contract before bid submission in addition to other terms & conditions.

Tender Evaluation

Tenders should be evaluated on the basis of the quoted PAC exclusive of taxes, except in the following cases

- (a) In cases where the bidders participated in a Tender consist of both registered and unregistered parties, Tenders shall be evaluated based on the total cash outflow to KSEBL. That is, the rates quoted by contractors excluding Taxes plus the GST (for registered parties) should be taken into consideration for the purpose of determining the L1 bidder.
- (b) If reverse charge is applicable for the subject work at the time of tender evaluation, KSEBL's liability on account of Reverse Charge Mechanism should also be considered (as cash outflow) in the evaluation of the tender.
- (c) If the bidder is a composite dealer (which can be identified from the GST registration certificate furnished by the bidder (Type of Registration – Composite) such contractors shall be evaluated as if they were unregistered contractors and clause (a) above shall be made applicable.
- (d) In case of tenders having PAC less than or equal to 20 lakhs, if the GST registration details were not specified by a registered bidder while submitting the Tender, he shall be treated as if he were an unregistered dealer. If the work was awarded to that bidder treating him as an unregistered dealer and at a later stage if it is found that he holds a valid GST registration, he should be insisted to provide GST invoice indicating the quoted amount and GST and in such a case the quoted amount shall only be reimbursed to him and the GST amount shall not be reimbursed.
- (e) TCS u/s 206C (1H) need not be considered for Tender evaluation.
- (f) This e-tender is being done in one cover system. Cover contains details related to document fees, Earnest Money Deposit (EMD) and bid agreement. NIT, general tender conditions, special conditions, technical conditions and other forms and bill of quantities.


All other terms and conditions existing in KSEBL for similar tenders are applicable to this also.
