Bidder should ensure that tender document fee (Rs. 8,900/-) and EMD (Rs. 1,11,200/-) are remitted as **one single transaction (ie Rs. 1,20,100/-)** and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transaction. EMD can not be furnished as BG. The **Internet Banking** facility for online payment may be exercised at least 48 hours before the closing date of the bid submission to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.
- The bid shall be submitted online and duly filled bid documents shall be uploaded in their designated online cover. The Bid shall be accepted only through online mode.
