CONDITIONS

1. All communications shall be addressed to the Executive Engineer, Project Management Unit, K.S.E.Board Ltd. Mini Vydyuthibhavanam, Nilambur-679329 only.
 2. The EMD and the non-refundable Tender document fee to be remitted online through MOPS(Multi Option Payment System) only. Bidder should ensure that tender document fee and EMD are remitted as one single transaction and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transaction. The MOPS facility for online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.
3. All the Tender documents are to be submitted online only and in the designated Covers/envelopes on the above website and no manual submission shall be entertained.
4. The scanned copies agreements executed in Kerala stamp paper worth Rs.200/- in each and all certificates /documents mentioned elsewhere in the bid documents are to be attached along with the bid through online. The bid shall be opened online at the office of the Executive Engineer, Project Management Unit, K.S.E.Board Ltd. Nilambur on the date and time mentioned above.
5. On getting the contract, the contractor shall execute a valid bond in adequate stamp paper legally agreeing the effect that he shall be liable to deposit the eligible amount towards compensation, funeral expense, interest and other liabilities if any payable as per the provisions of the Employees Compensation Act 1923 to the contract workers working under him on behalf of any fatal/ non-fatal accidents if any occurred to the employees while carrying out the work.
6. The contractor shall obtain an insurance coverage in respect of the employees engaged by him from a nationalised / at par insurance Company by paying adequate premium to cover the compensation payable in case of fatal/ non fatal accidents if any occurred to the employees while carrying out the work. The policy document in original shall be submitted to this office to attach with the work order and to retain in the safe custody at the office.
7. The insurance coverage obtained as per the above shall be sufficient enough to cover all the expenses payable on behalf of the fatal/ non fatal accident victims viz hospital expenses, half monthly compensation, funeral expenses, compensation (death and disablement total and partial) interest @ 12% payable from the date of accident to the date of deposit of compensation and other financial benefits payable as per the provisions of the employees compensation act 1923.
8. If the period of validity of the insurance expired before the completion of the work, the same shall be extended/renewed or obtained new policy with sufficient period of validity till the completion of work.
9. In case of any accident to the employees engaged by the contractor, the work bill of the contractor shall not be settled unless and until eligible amount of compensation and other financial benefit are deposited before the Commissioner for Employees Compensation as per the provisions of the Employees Compensation act 1923.
10. Any liability on the difference in compensation amount and interest to be deposited before the Commissioner of Employees Compensation or to the victim beyond the insurance claim amount sanctioned by the insurance Company rests with the contractor who has engaged the victim.
