In case of work contracts or pure labor contracts, the bidder shall quote single GST rate for the work. The bidder should possess valid PAN card and copy of the same shall be uploaded. The experience certificate for the similar works done shall be uploaded. Copy of the same shall be uploaded In case of Bidding as joint venture agreement and power of attorney shall be uploaded.
