Separate or split remittance for bid document fee and EMD shall be treated as invalid transactions, and system will automatically reject the tender. The MOPS facility for online payment may be exercised at least 48Hrs before the closing date of the

bid to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

The offers shall be submitted in single bid system. All bid documents are to be submitted online and in the designated covers/envelops on the above website. Bid shall be accepted only through online mode in the website and no manual submission shall be entertained.

The contractor undertaking the work shall obtain an insurance coverage (All riskcover) in respect of workmen engaged by him from a Nationalized Insurance Company which shall be sufficient enough to cover all the expenses payable on behalf of fatal/non fatal accident victims including hospital expenses, HMC, funeral benefit/compensation (death and disablement total and partial) and other financial benefits payable as per provision of employees compensation Act, 1923. Any liability on the difference in compensation amount payable before the commissioner for workmen's compensation(Deputy labour Commissioner) or the victim beyond the insurance claim amount sanctioned by the Insurance Company rest with the contractor who has engaged the victim.

All other terms and conditions existing in Kerala State Electricity Limited for similar tenders are applicable to this also.
